B. 5311 Grant application for year Oct 2020 to September 2022 update:

The grant has been approved. It is for approximately \$120,000 the first year. \$114,000 of the CARES Act funding from the past year will roll over to the next year. A new bus has been approved. Funding is a 90/10 split. The Senior Center has already paid it's share. The bus should arrive next week. It is an ARBOC Spirit of Freedom with a wheelchair ramp.

The ramp users will be able to board on their own as the incline is very slight – almost ground level - and goes straight into the bus.

 - 1. Bus Ridership to Date:

A discussion of possible reasons for decreased ridership included:

People may be afraid to ride the bus due to COVID concerns

Hesitation of the public to be out and about – the uptick in the virus is weighed by people before deciding to go out

People don't have places to go due to COVID restrictions

A suggestion to help increase ridership is to make the public aware of what is being done to make riding the bus as safe as possible through the media such as newspaper and radio

2. Rider Comment Cards:

Haven't been doing the comment cards due to health concerns with more than one person handling the cards and commenters using the same pen/pencil to fill them out. A discussion of possible methods to obtain comments included use of iPad or other virtual methods, texting, disposable writing instruments, or pencils the commenters get to keep.

3. Bus Safety

Once a month training for drivers and staff. MAG had a webinar that drivers and staff participated in.

4. Budget and Expenditures

Please see the "E-Grants" document. included with these minutes In February 2020, received \$240,000 CARES Act money, \$114,000 is left. February through September funding was CARES Act money. Local partners put out no additional money.

- B. 5339 Grant Trevor to Update

This grant includes sidewalk, pedestrian, and bus stop improvements. Some items require design plans and some don't. For those that don't, construction could start in a couple months. For the remaining items, design plans will need to be prepared prior to beginning construction. The projected timeframe is to prepare the plans during the winter with construction starting when the weather is warmer. Any road construction in the area of the grant would use HURF money (Highway User Revenue Funds).

There is no information on the North McLane improvement grant yet.
